THESE UPGRADES WERE FUNDED BY A FOUNDATION GRANT FROM WELLS FARGO. CSS ALSO PURCHASED A HYDRAULIC DUMP TRAILER AND OTHER TOOLS WITH THE SAME FUNDS FOR THE PURPOSES OF FIREWOOD PICK UP AND DISTRIBUTION.
